

## **TERMS AND CONDITIONS**

### **TERMS OF USE**

By registering, the User declares to have read and accepted these terms of use (from now on CdU). Each part of the following conditions is to be considered an integral part of the same.

The game "Buraco Plus" is provided by Oryx Technology with registered office in Doha, P.O. BOX 24186, email:support@oryxtechnology.com.

#### **1 - ACCOUNT**

1.1 To create a "Buraco Plus" Account, you must have a valid e-mail address or Apple, Google or Facebook account and provide true and accurate information. You must be at least 16 years old (or other minimum age required in your country of residence) to create a "Buraco Plus" Account. If you are between the minimum age required and 18 (or the age of majority in your country of residence), you must review this Agreement with your parent or legal guardian. Parents and legal guardians are responsible for the actions of children under the age of 18 when they use the services of "Buraco Plus". The User guarantees the veracity of the information provided, related to identity and electronic address, required during the registration phase.

1.2 The use of the Service is subject to the following restrictions:

- You may not sell, rent or donate your Account, create Accounts using a false identity or providing false information, or create an Account on behalf of others;
- You may not share your Account with others;
- You will only use Your Account for non-commercial purposes, and You will not use Your Account to advertise, solicit, or transmit to anyone commercial announcements, including chain letters, unsolicited e-mails, or repetitive messages.

1.3 You may terminate this Agreement at any time by requesting deletion of your Account.

1.4 The creation of the account and the game "Buraco Plus", with the Free profile, are totally free of charge and there is no charge for the User. Some other services provided by "Buraco Plus" may not be free and provide a paid subscription, in these cases will be given appropriate information on how to join.

#### **2 - CHAT AND COMMUNITY**

2.1 Oryx Technology provides a platform in the game "Buraco Plus" that allows Users to communicate with each other. The User assumes all responsibility and liability for the content and form of messages and/or material posted on the network through the "Buraco Plus" platform.

2.2 Oryx Technology is not responsible for the content shared by Users.

2.3 The User acknowledges that he/she is solely and exclusively responsible for the activities carried out through the Service or directly or indirectly attributable to him/her, and in particular that he/she is responsible for the content and communications inserted, published, disseminated and transmitted on or through the Services.
